- Select **Omaha** as the Acquirer platform; select **Omaha, Nashville, Buypass, or Cardnet (North Bridge)** as the Authorization Network.
- When adding the work order, select Merchant Account Update as the work order category. For Legal Business Name changes, select
 Legal Information Update for the work order type. For IRS Name/Taxpayer ID changes, Fed Tax ID/IRS Name for the work order
 type.

Pertinent items of note when completing the form:

- Please select the platform(s) for which you the changes are going to apply. Also, please provide the MIDs for all platforms for which changes will be made. This will ensure that changes are made to both the authorization (front-end) and settlement (back-end) platforms.
